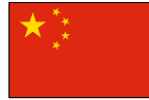

Achievements in 2020:

We have a lot of potential players to build the Badminton nation, a group of enthusiastic administrative staff always desire to work hard for Bangladesh Badminton. We organized National championship, Junior and Sub-Junior. The training camp of national junior group, the training program of talented players selected from grassroots level, Bangabandhu Bangladesh Senior Ranking Tournament-2020, Bangabandhu Bangladesh Junior Ranking Tournament-2020, BWF Level-1 Coaches Course-2020 to make Badminton popular in Bangladesh as well as would with limited resources and unlimited challenges.

Ten coaches of Bangladesh successfully reached level-1. Our team has won bronze medal in Mixed Doubles event in the SA Games in Nepal, Women’s Double and Mixed Doubles in the Nepal International Series. Besides, Bangladesh won the bronze medal in the Badminton Asia Regional team and individual championship.

Bangladesh has produced one BWF certified Umpire and three BA accredited umpires those who are conducting tournaments including super series. Bangladesh produces BWF level 2 and level 1 coaches and Tutors for BWF Level 1 and Shuttle time. We have organized regional umpires’ course, regional players training camp, regional coaches’ clinic several times as a regional development centre supported by Badminton Asia and BWF.

Achievements in 2020:

- a) Players:
 - The Federation conducted 11 days of foundational winter coaching camp for kids in Thimphu from 25 December 2019-7 January 2020. Around 30 kids participated in the coaching camp.
 - The Federation conducted an advanced Winter Training Camp for the selected Junior Players from 11-25 January 2020. 18 girls and 24 boys

participated in the training at the Babena Badminton hall, Thimphu.

- b) Administration:
 - The Federation signed a memorandum of understanding with the National Anti-Doping Organization (Bhutan Olympic Committee) and Bhutan Anti-Doping Committee (BADC) to ensure clean badminton sport in Bhutan on 12 December 2020.

- Coinciding with the 41st Birth Anniversary of His Majesty the King on 21 February 2021, the Bhutan Badminton Federation in a humble ceremony celebrated the occasion with the launch of a website and membership card for member players (recreational).

- c) Events:
 - The Federation organized the 19th U19 Open National Badminton Championship 2020 from 27th - 30th January 2020 at Bebena Badminton Hall. A total of 24 boys and 22 girls participated in the championship.

- d) Technical Official:
 - The Coaches of the Federation attended the online South Asian Umpire Course through BlueJeans, an online platform from 16-22 July 2020. Through the course, the Coaches were educated on new and updated Law of Badminton.

- Mr. Dorji, National Shuttle Time Coordinator successfully conducted an online Shuttle Time Course for interested School Sports Instructors (SSIs), Teachers and Badminton enthusiast on 22 August 2020 during the nationwide lockdown caused by the COVID 19 Pandemic.

- The three Coaches attended the 3-day introductory workshop on developing General Fitness Test for national athletes from 27-29 July 2020.

- The Coaches attended an online Coach Adoption program initiated by the Badminton Asia to learn about challenges faced during the training of national players and strategies and means to overcome the challenges.



e) Development:

- The Federation provided foundational coaching to 73 students of Punakha District from 10th to 13th February 2020 as a part of Youth Enrichment Program coordinated by the Games and Sports Division of the Ministry of Education.

- The Federation conducted shuttle time kids' course for the students of Thimphu Dzongkhag from 1st to 10th August 2020. 11 boys and 15 girls participated in the course.

- The Federation conducted shuttle time teachers' course at Trashigang District from 14th-15th November 2020. The two-day course saw 25 teacher participants.

- The Federation conducted shuttle time teachers' course at Rangjung Lower Secondary school on November 19 and 20, 2020. The shuttle time coordinator also conducted shuttle time course for the 16 monks of Samkhar Goenpa (Monastery) under the same district. Similarly, the same course was also conducted for the 50 monks of Chador Lhakhang (temple) in another village.

- The Federation conducted a Coach Adoption program at three different venues from 2nd-7th December with support from BA. A total of 49 boys and 60 girls participated in the program.

In 2020, CBA upheld several national tournaments, including Inter-Team China Contest, World Junior Mixed-group Championship Simulation Contest, China Badminton Super League, China National Championships, Badminton Carnival

&Thomas Cup Simulation Contest. We have accumulated great experience in upholding international tournaments.

The registering and management of Coaches and Players:

in 2020, CBA registered 2323 players, including 1439 male players and 884 female players. CBA also put 2796 players on archives including 1768 male players and 1028 female players. Besides, CBA assessed and issued titles of international master of sports, master of sports to 37 players in 3 times.

For Coaches, CBA registered 344 coaches, including 256 male coaches and 88 female coaches. The number of players and coaches is increasing. We organized two training sessions for coaches to improve their capability.

The registering and management of Umpires:

in 2020, CBA recorded 572 registered national umpires. CBA delivered 160 umpires for 6 tournaments in total last year. We have also successfully recommended 1 international line judge to BWF. Those umpires met the demands on tournaments without mistakes and disputes. We organized 1 training session for umpire this year to improve their capacity.

Operation of CBA

In 2020, in strict accordance with the COVID-19 prevention arrangement led by the China General Administration of Sport, CBA implemented the related work responsibility with a highly effective performance in the prevention and control of COVID-19.

For the market expansion, CBA optimized and improved the industry plan, strengthened the guidance of the sport by multiple measures in accordance with the law and regulations.

For the young talent cultivation, CBA steadily promoted the training of reserving youth talents, built a reasonable youth training system; We have work on the in-depth implementation of the integration of



sports and education by cooperating deeply with sports associations in Universities and High schools continually so as to comprehensively promote badminton in campus.

We have followed a strict anti-doping management method with related education and anti-doping measures for badminton.

In conclusion, CBA has been increasing the promotion of badminton and expanding the mass base of badminton in China.

Under the pandemic situation in 2020, some of HKBA activities were suspended or cancelled. Two local competitions and about 150 training courses were organized in consideration of pandemic development and government COVID-19 prevention policy.

In early 2020, Hong Kong Team awarded 1 gold and 4 bronze medals at international events. NG Ka Long world ranked 8 in Men's Singles and TANG Chun Man/TSE Ying Suet world ranked 10 in Mixed Doubles.

There are 270 HKBA registered coaches, 257 HKBA registered umpires among which there are 1 BWF Referee, 3 BAC Referees, 4 BWF Umpires and 3 BAC Umpires. They are all under strict supervision and comply with the Code of Conduct.

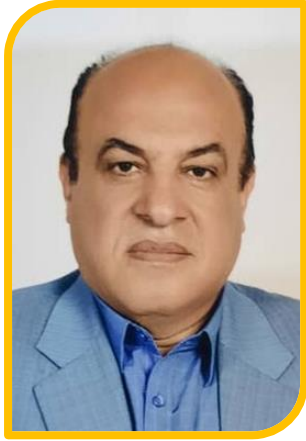
Indonesian Men's Doubles pair also gained silver through Fajar Alfian and Muhammad Rian Ardianto.

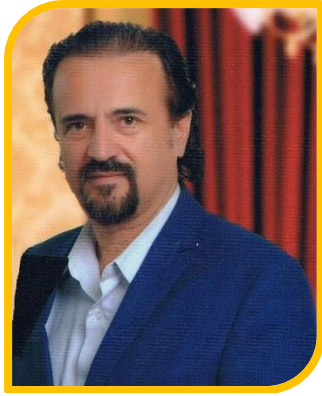

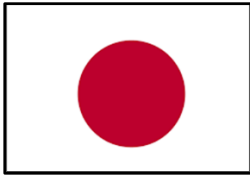

Development and reform of Macau local tournaments to promote the popularity of badminton in Macau

I have been involved in badminton for over 20 years. After years of effort, badminton has become one of the most popular sports in Macau. Various and different levels of local tournaments (Fourteen fixed local tournaments per year) have been introduced and organized for the public, government, enterprises and social associations in order to promote and enhance the popularity of badminton in Macau.

Major Achievement of Badminton Federation of Macau in 2020

2020 was a great challenge to every one of us, with the pandemic outbreak through all over the world.

In local tournaments, under the influence of this pandemic, only 3 of the major local tournaments were held successfully in Macau.

However, participants in these tournaments were increased in this circumstance, which made these 3 held tournaments a great success and unfortunately, the Macau National Team was able to attend the first and only one tournament in the near neighbourhood, Zhuhai, Guangdong Province and got remarkable results.

But unfortunately, the yearly-host international tournament, 2020 Macau Open Badminton, Part of the HSBC BWF World Tour was cancelled.

In local events, Badminton Federation of Macau remains assisting local government departments, institutions and companies in organizing badminton events as a co-organizer, meanwhile providing technical official service in 5 local events.

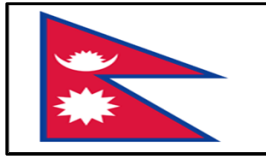

Although not allowed to join the cycling team, I was still allowed to join other sports team. This is where I started to join the badminton training team in Senior high and won many local championships. I used to not have any trainer or good rackets, but I did my best to observe, apply what I learned, and train. I joined more championships inside Timor-Timur and with the blessings of my parents; I was given the privilege to be able to join trainings outside the country like Indonesia. In one of the championships in Bandung, I won as 3rd and won as 1st in Jakarta.

After my mother passed, I refused to outside Timor-Timur therefore, I just joined championships inside of Timor and refused to go out even though I was given the opportunity to due to the fact that I was the eldest son and I feel responsible for my other younger siblings.

During the separation of Timor-Timur from Indonesia, resulting the name of “Timor-Leste” in 1999, I joined the Badminton National team of Timor-Leste. In the year 2000, I was sent to the training center in Darwin for the Olympic. In 2002, I



represented Timor-Leste in the Asian Games that was held in Busan, Korea and also the Asian Games that was held in Doha, Qatar in 2006.

After retiring from becoming an athlete in Badminton, I was chosen by the fellow badminton friends, officers and athletes, especially the first president of FBTL, the late Sr. Mariano Lopes to join the FBTL to continue the programs and promote its growth. Since then, I have been involved with the FBTL and continued to do my best to promote growth to Badminton in Timor-Leste.

MAJOR ACHIEVEMENT 2020

Pandemic had cause major cancellation of programs and activities in FBTL. However following highlights are the achievements of the associations;

- Annual Regional Junior and Senior Championship in Dili, Timor-Leste
- Sending off athletes to Sea Games in Jakarta and Palembang in 2011
- Giving off chance for the junior athletes to train in Djarum, Kudus Indonesia in 2018 and play in the Junior Championship in Jogja.
- Sending off trainees to train in Ick Sugiarto's training camp.
- Giving of seminars and legalization of coaching

- Musical Night by Development. The world may be experiencing massive impact due to the COVID-19 outbreak, but this has not stopped Badminton Asia Development

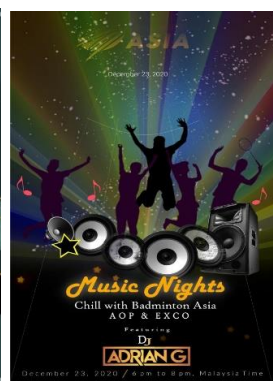
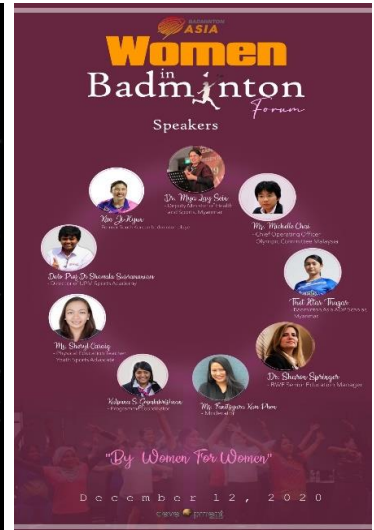

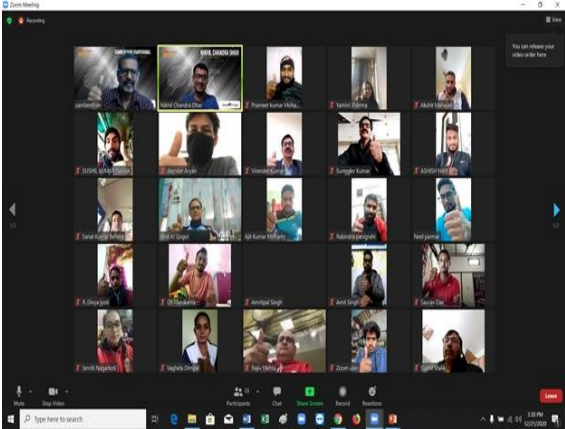
5.0 COACH EDUCATION

NOTES TO THE FINANCIAL STATEMENTS

1. GENERAL INFORMATION

The principal activities of the Confederation are those of promoting, managing and developing the badminton sport in Asia in principles of specificity and universality.

The Confederation is registered in Malaysia under the Societies Act, 1966.

The financial statements are presented in Ringgit Malaysia (“RM”), which is also the functional currency of the Confederation.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation

The financial statements of the Confederation have been prepared in accordance with the Malaysian Financial Reporting Standards (“MFRSs”), International Financial Reporting Standards and the requirements of the Societies Act, 1966 in Malaysia.

The financial statements of the Confederation have been prepared under the historical cost basis, other than as disclosed in the significant accounting policies in Note 2.3 to the financial statements.

The preparation of financial statements in conformity with MFRSs requires the use of certain critical accounting estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of the revenue and expenses during the reported period. It also requires Management Committee to exercise their judgement in the process of applying the Confederation’s accounting policies. Although these estimates and judgement are based on the Management Committee’s best knowledge of current events and actions, actual results may differ.

The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements are disclosed in Note 2.4 to the financial statements.

2.3 Significant Accounting Policies

The following accounting policies have been used consistently in dealing with items which are considered material in relation to the financial statements: -

(a) Plant and Equipment and Depreciation

All plant and equipment are initially stated at cost. After recognition as an asset, items of plant and equipment are carried at cost less accumulated depreciation and any accumulated impairment losses. The policy for the recognition and measurement of impairment losses is in accordance with Note 2.3(f) to the financial statements.

Cost includes expenditure that is directly attributable to the acquisition of the asset. When significant parts of an item of plant and equipment have different useful lives, they are accounted for as separate items of plant and equipment.

The cost of replacing part of an item of plant and equipment is included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that the future economic benefits associated with the part will flow to the Confederation and its cost can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the profit or loss as incurred.

Depreciation is provided on a straight-line method so as to write off the depreciable amount of the following assets over their estimated useful lives, as follows:

Depreciation of an asset begins when it is ready for its intended use.

The residual values, useful lives and depreciation are reviewed, and adjusted as appropriate, at the end of each reporting period. The effects of any revisions of the residual value and useful lives are included in the profit or loss for the financial year in which the changes arise.

An item of plant and equipment is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset is included in the profit or loss in the financial year the asset is derecognised.

(b) Financial Instruments

Recognition and initial measurement

Financial instruments are recognised in the statements of financial position when, and only when, the Confederation becomes a party to the contract provisions of the financial instrument.

A financial instrument is recognised initially, at its fair value, plus, in the case of a financial instrument not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition or issue of the financial instrument.

An embedded derivative is recognised separately from the host contract and accounted for as a derivative if, and only if, it is not closely related to the economic characteristics and risks of the host contract and the host contract is not categorised at fair value through profit or loss. The host contract, in the event an embedded derivative is recognised separately, is accounted for in accordance with policy applicable to the nature of the host contract.

Financial instrument categories and subsequent measurement

Financial assets

The categories of financial assets are determined on initial recognition and are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets in which case all affected financial assets are reclassified on the first day of the first reporting period following the change of the business model.

(i) Amortised cost

Amortised cost category comprises financial assets that are held within a business model whose objective is to hold assets to collect contractual cash flows and its contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The financial assets are not designated as fair value through profit or loss. Subsequent to initial recognition, these financial assets are measured at amortised cost using the effective interest method. The amortised cost is reduced by impairment losses. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain or loss on derecognition is recognised in profit or loss.

Interest income is recognised by applying effective interest rate to the gross carrying amount except for credit impaired financial assets as disclosed in Note 2.3(f) to the financial statements, where the effective interest rate is applied to the amortised cost.

(ii) Fair value through other comprehensive income

(a) Debt investments

Fair value through other comprehensive income category comprises debt investment where it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling the debt investment, and its contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The debt investment is not designated as at fair value through profit or loss. Interest income calculated using the effective interest method, foreign exchange gains and losses and impairment are recognised in profit or loss. Other net gains and losses are recognised in other comprehensive income. On derecognition, gains and losses accumulated in other comprehensive income are reclassified to profit or loss.

Interest income is recognised by applying effective interest rate to the gross carrying amount except for credit impaired financial assets, where the effective interest rate is applied to the amortised cost.

(b) Equity investments

This category comprises investment in equity that is not held for trading, and the Confederation irrevocably elect to present subsequent changes in the investment's fair value in other comprehensive income. This election is made on an investment-by-investment basis. Dividends are recognised as income in profit or loss unless the dividend clearly represents a recovery of part of the cost of investment. Other net gains and losses are recognised in other comprehensive income. On derecognition, gains and losses accumulated in other comprehensive income are not reclassified to profit or loss.

(iii) Fair value through profit or loss

All financial assets not measured at amortised cost or fair value through other comprehensive income as described above are measured at fair value through profit or loss. This includes derivative financial assets (except for a derivative that is a designated and effective hedging instrument). On initial recognition, the Confederation may irrevocably designate a financial asset that otherwise meets the requirements to be measured at amortised cost or at fair value through other comprehensive income as at fair value through profit or loss if doing so eliminates or significantly reduces an accounting mismatch that would otherwise arise.

Financial assets categorised as fair value through profit or loss are subsequently measured at their fair value. Net gains or losses, including any interest or dividend income, are recognised in the profit or loss.

Financial assets (Continued)

All financial assets, except for those measured at fair value through profit or loss and equity investments measured at fair value through other comprehensive income, are subject to impairment assessment.

Financial liabilities

The categories of financial liabilities at initial recognition are as follows:-

(i) Financial liabilities at fair value through profit or loss

Fair value through profit or loss category comprises financial liabilities that are derivatives (except for a derivative that is a financial guarantee contract or a designated and effective hedging instrument), contingent consideration in a business combination and financial liabilities that are specifically designated into this category upon initial recognition.

On initial recognition, the Confederation may irrevocably designate a financial liability that otherwise meets the requirements to be measured at amortised cost as at fair value through profit or loss:-

- (a) if doing so eliminates or significantly reduces an accounting mismatch that would otherwise arise;
- (b) a group of financial liabilities or assets and financial liabilities is managed and its performance is evaluated on a fair value basis, in accordance with a documented risk management or investment strategy, and information about the group is provided internally on that basis to the Confederation's key management personnel; or
- (c) if a contract contains one or more embedded derivatives and the host is not a financial asset in the scope of MFRS 9, where the embedded derivative significantly modifies the cash flows and separation is not prohibited.

Financial liabilities categorised as fair value through profit or loss are subsequently measured at their fair value with gains or losses, including any interest expense are recognised in the profit or loss.

For financial liabilities where it is designated as fair value through profit or loss upon initial recognition, the Confederation recognise the amount of change in fair value of the financial liability that is attributable to change in credit risk in the other comprehensive income and remaining amount of the change in fair value in the profit or loss, unless the treatment of the effects of changes in the liability's credit risk would create or enlarge an accounting mismatch.

(ii) Amortised cost

Other financial liabilities not categorised as fair value through profit or loss are subsequently measured at amortised cost using the effective interest method.

Interest expense and foreign exchange gains and losses are recognised in the profit or loss. Any gains or losses on derecognition are also recognised in the profit or loss.

Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument.

Financial guarantees issued are initially measured at fair value. Subsequently measured at higher of:-

- the amount of the loss allowance; and
- the amount initially recognised less, when appropriate, the cumulative amount of income recognised in accordance to the principles of MFRS 15, Revenue from Contracts with Customers.

Liabilities arising from financial guarantees are presented together with other provisions.

Regular way purchase or sale of financial assets

Settlement date accounting refers to:-

- (i) the recognition of an asset to be received and the liability to pay for it on the trade date, and
- (ii) derecognition of an asset that is sold, recognition of any gain or loss on disposal and the recognition of a receivable from the buyer for payment on the trade date.

Any change in the fair value of the asset to be received during the period between the trade date and the settlement date is accounted in the same way as it accounts for the acquired asset.

Generally, the Confederation applies settlement date accounting unless otherwise stated for the specific class of asset.

Derecognition

A financial asset or part of it is derecognised when, and only when the contractual rights to the cash flows from the financial asset expire or transferred, or control of the asset is not retained or substantially all of the risks and rewards of ownership of the financial asset are transferred to another party. On derecognition of a financial asset, the difference between the carrying amount of the financial asset and the sum of consideration received (including any new asset obtained less any new liability assumed) is recognised in profit or loss.

A financial liability or a part of it is derecognised when, and only when, the obligation specified in the contract is discharged, cancelled or expires. A financial liability is also derecognised when its terms are modified and the cash flows of the modified liability are substantially different, in which case, a new financial liability based on modified terms is recognised at fair value. On derecognition of a financial liability, the difference between the carrying amount of the financial liability extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Offsetting

Financial assets and financial liabilities are offset and the net amount presented in the statements of financial position when, and only when, the Confederation currently has a legally enforceable right to set off the amounts and it intends either to settle them on a net basis or to realise the asset and liability simultaneously.

(c) Provision for Liabilities

Provision for liabilities are recognised when the Confederation has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of economic resources will be required to settle the obligation and the amount of the obligation can be estimated reliably.

Provisions are reviewed at the end of each reporting period and adjusted to reflect the current best estimate. If it is no longer probable that an outflow of economic resources will be required to settle the obligation, the provision is reversed. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, where appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

(d) Leases

The Confederation has applied MFRS 16, Leases using the modified retrospective approach, under which the cumulative effect of initial application is recognised as an adjustment to retained earnings at 1 January 2019. Accordingly, the comparative information presented for 2018 has not been restated.

Recognition and initial measurement

As a lessee

The Confederation recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any incentives received.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Confederation's fixed deposit's rate. Generally, the Confederation uses its fixed deposits rate as the discount rate.

Lease payments included in the measurement of the lease liability comprise the following:

- fixed payments (including in-substance fixed payments) less any incentives receivable;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable under a residual value guarantee;
- the exercise price under a purchase option that the Confederation is reasonably certain to exercise; and
- penalties for early termination of a lease unless the Confederation is reasonably certain not to terminate early.

The Confederation exclude variable lease payments that linked to future performance or usage of the underlying asset form the lease liability. Instead, these payments are recognised in profit or loss in the period in which the performance or use occurs.

The Confederation has elected not to recognise right-of-use and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of low-value assets. The Confederation recognises the lease payments associated with these leases as an expense in profit or loss on a straight-line basis over the lease term.

As a lessor

When the Confederation acts as a lessor, it determines at lease commencement whether each lease is a finance lease or an operating lease.

To classify each lease, the Confederation makes an overall assessment of whether the lease transfers to the lessee substantially all of the risks and rewards of ownership incidental to ownership of the underlying asset. If this is the case, then the lease is a finance lease; if not, then it is an operating lease. As part of this assessment, the Confederation considers certain indicators such as whether the lease is for the major part of the economic life of the asset.

When the Confederation is an intermediate lessor, it accounts for its interests in the head lease and the sub-lease separately. It assesses the lease classification of a sub-lease with reference to the right-of-use asset arising from the head lease, not with reference to the underlying asset. If a head lease is a short-term lease to which the Confederation applies the exemption described above, then it classifies the sub-lease as an operating lease.

If an arrangement contains lease and non-lease components, the Confederation applies MFRS 15 to allocate the consideration in the contract.

Subsequent measurement

As a lessee

The right-of-use asset is subsequently depreciated using the straight-line basis from the commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term as follows:-

In addition, the right-of-use asset is periodically reduced by impairment losses, if any, and adjusted for certain remeasurements of the lease liability.

The lease liability is measured at amortised cost using the effective interest method. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, or if there is a change in the Confederation estimate of the amount expected to be payable under a residual value guarantee, or if the Confederation changes its assessment of whether it will exercise a purchase, extension or termination option.

When the lease liability is remeasured, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

As a lessor

The Confederation recognises lease payments received under operating leases as income on a straight-line basis over the lease term as part of “revenue”.

Prior to 1 January 2019

(i) Finance lease

Leases in term of which the Confederation assumed substantially all the risks and rewards of ownership were classified as finance leases. Upon initial recognition, the leased asset was measured at an amount equal to the lower of its fair value and the present value of the minimum lease payments. Subsequent to initial recognition, the asset was accounted for in accordance with the accounting policy applicable to that asset.

Minimum lease payments made under finance leases were apportioned between the finance expense and the reduction of the outstanding liability. The finance expense was allocated to each period during the lease term so as to produce a constant periodic rate of interest on the remaining balance of the liability. Contingent lease payments were accounted for by revising the minimum lease payments over the remaining term of the lease when the lease adjustment was confirmed.

(ii) Operating lease

Leases, where the Confederation did not assume substantially all the risks and rewards of ownership were classified as operating leases and, the leased assets were not recognised on the statement of financial position.

Payments made under operating leases were recognised in profit or loss on a straight-line basis over the lease. Lease incentive were recognised in profit or loss as an integral part of the total lease expense, over the term of the lease. Contingent rentals were charged to profit or loss in the reporting period in which they were incurred.

(e) Foreign Currency Translation

(i) Foreign Currency

The functional currency of the Confederation is the currency of the primary economic environment in which the Confederation operates. Ringgit Malaysia (“RM”) is the functional currency.

The financial statements of the Confederation are presented in US Dollar which is the presentation currency.

(ii) Transactions in Foreign Currencies

Transactions in foreign currencies are translated into functional currency at rates of exchanges ruling at the time of transactions and where settlement had not taken place by 31 December 2019 at the approximate rates ruling as at that date. All gains and losses on exchange are included in the income and expenditure statement.

(iii) Translation of Foreign Currency Financial Statements

Foreign assets and liabilities are translated into US Dollar at exchange rates ruling at the date of statement of financial position. Income and expenditure statement items are translated at the average rate of exchange for the financial year. The translation differences arising there from are recorded as movements in translation reserve.

(f) Cash and Cash Equivalents

For the purpose of the statements of cash flows, cash and cash equivalents comprise of cash in hand, bank balances, demand deposits and other short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value. Cash and cash equivalents are stated at net of bank overdrafts and deposits pledged to the financial institution.

(g) Impairment

The Confederation assesses at the end of each reporting period whether there is any objective evidence that a financial asset is impaired.

(i) Impairment of Financial Assets

Other receivables

To determine whether there is objective evidence that an impairment loss on financial assets have been occurred, the Confederation considers factors such as the probability of insolvency or significant delay in payments. For certain categories of financial assets, such as other receivables, assets that are assessed not to be impaired individually are subsequently assessed for impairment on a collective basis based on similar characteristics. Objective evidence of impairment for a portfolio of receivables could include the Confederation's past experience of collecting payments, an increased in the number of delayed payments in the portfolio past the average credit period and the observable changes in national or local economic conditions that correlate with default on receivables.

If any such evidence exists, the amount of impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate. The impairment loss is recognised in profit or loss.

The carrying amount of the financial asset is reduced by the impairment loss directly for all financial assets with the exception of other receivables, where the carrying amount is reduced through the use of an allowance account. When the other receivable becomes uncollectible, it is written off against the allowance account.

If in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment loss was recognised, the previously recognised impairment loss is reversed to the extent that the carrying amount of the asset does not exceed its amortised cost at the reversal date. The amount of reversal is recognised in profit or loss.

Unquoted equity securities carried at cost

If there is objective evidence (such as significant adverse changes in the business environment where the issuer operates, probability of insolvency or significant financial difficulties of the issuer) that an impairment loss on financial assets carried at cost had been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the current market rate of return for a similar financial asset. Such impairment losses are not reversed in subsequent periods.

(ii) Impairment of Non-financial Assets

The Confederation assesses at the end of each reporting period whether there is an indication that an asset may be impaired. If any such indication exists, or when an annual impairment assessment for an asset is required, the Confederation makes an estimate of the asset's recoverable amount.

An asset's recoverable amount is the higher of an asset's fair value less costs to sell and its value in use. For the purpose of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units ("CGU")).

In assessing value in use, the estimated future cash flows expected to be generated by the asset are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where the carrying amount of an asset exceeds its recoverable amount, the asset is written down to its recoverable amount. Impairment losses recognised in respect of a CGU or groups of CGUs are allocated first to reduce the carrying amount of any goodwill allocated to those units or groups of units and then, to reduce the carrying amount of the other assets in the unit or groups of units on a pro-rata basis.

Impairment losses are recognised in profit or loss except for assets that are previously revalued where the revaluation was taken to other comprehensive income. In this case, the impairment is also recognised in other comprehensive income up to the amount of any previous revaluation.

An assessment is made at the end of each reporting period as to whether there is any indication that previously recognised impairment losses may no longer exist or may have decreased. A previously recognised impairment loss is reversed only if there has been a change in the estimates used to determine the asset's recoverable amount since the last impairment loss was recognised. If that is the case, the carrying amount of the asset is increased to its recoverable amount. That increase cannot exceed the carrying amount that would have been determined, net of depreciation, had no impairment loss been recognised previously. Such reversal is recognised in profit or loss unless the asset is measured at revalued amount, in which case the reversal is treated as a revaluation increase. Impairment loss on goodwill is not reversed in a subsequent period.

(h) Government grant

Government grants that do not impose specified future performance conditions are measured at the fair value of the assets received or receivable and recognised in income when the grant proceeds are receivable.

Government grants that impose specified future performance conditions are recognised at their fair value in income only when the performance conditions are met.

Government grants received before the revenue recognition criteria are satisfied are recognised as a liability.

(i) Income recognition

Revenue is measured at the fair value of the consideration received or receivable, net of any discounts, rebates, returns and taxes collected on behalf of government. Revenue is recognised to the extent that it is probable that economic benefits associated with the transactions will flow to the Confederation.

(j) Employee Benefits

(i) Short Term Employee Benefits

Wages, salaries, social security contribution, bonuses and non-monetary benefits are accrued in the period in which the associated services are rendered by the employees. Short term accumulating compensated absences such as paid annual leave is recognised when services rendered by the employees that increase their entitlement to future compensated absences. Short term non-accumulating compensated absences such as sick leave is recognised when the absences occur.

(ii) Post-employment Benefits

The Confederation contributes to the Employees' Provident Fund, the national defined contribution plan. The contributions are charged to the profit or loss in the period to which the related service is performed. Once the contributions have been paid, the Confederation has no further payment obligations.

(k) Income Tax

The tax expense in the profit or loss represents the aggregate amount of current tax and deferred tax. Current tax and deferred tax are recognised in profit or loss except to the extent that they relate to a business combination or items recognised directly in equity or other comprehensive income.

Current tax expense is the expected tax payable or receivable in respect of the taxable profit or loss for the financial year and is measured using the tax rates that have been enacted or substantively enacted by the end of the reporting period, and any adjustment to tax payable in respect of previous years.

(k) Income Tax (Continued)

Deferred tax is recognised using the liability method, providing for temporary differences between the carrying amounts of assets and liabilities in the statement of financial position and their tax bases. Deferred tax is not recognised for the following temporary differences: the initial recognition of goodwill, the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit or loss. Deferred tax is measured at the tax rates that are expected to apply to the temporary differences when they reverse, based on the laws that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and liabilities are offset if there is a legally enforceable right to offset current tax liabilities and assets, and they relate to income taxes levied by the same tax authority on the same taxable entity, or on different tax entities, but they intend to settle current tax liabilities and assets on a net basis or their tax assets and liabilities will be realised simultaneously.

A deferred tax asset is recognised to the extent that it is probable that future taxable profits will be available against which the temporary difference can be utilised. Deferred tax assets are reviewed at the end of each reporting period and are reduced to the extent that it is no longer probable that the related tax benefit will be realised.

A tax incentive that is not a tax base of an asset is recognised as a reduction of tax expense in profit or loss as and when it is granted and claimed. Any unutilised portion of the tax incentive is recognised as a deferred tax asset to the extent that it is probable that future taxable profits will be available against which the unutilised tax incentive can be utilised.

2.4 Significant Accounting Estimates and Judgements

The preparation of the Confederation's financial statements requires Management Committee to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the disclosure of contingent liabilities at the end of the reporting period. However, uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amount of the asset or liability affected in the future.

(a) Judgements Made in Applying Accounting Policies

There are no critical judgements made by the Management Committee in the application of accounting policies of the Confederation that has a significant effect on the financial statements.

(b) Key Sources of Estimation Uncertainty

The key assumption concerning the future and other key sources of estimation uncertainty at the end of the reporting period that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are as stated below: -

(i) Useful Lives of Plant and Equipment

The Confederation estimates the useful lives of plant and equipment based on the period over which the assets are expected to be available for use. The estimated useful lives of plant and equipment are reviewed periodically and are updated if expectations differ from previous estimates due to physical wear and tear, technical or commercial obsolescence and legal or other limits on the use of the relevant assets.

In addition, the estimation of the useful lives of plant and equipment are based on internal technical evaluation and experience with similar assets. It is possible, however, that future results of operations could be materially affected by changes in the estimates brought about by changes in factors mentioned above. The amounts and timing of recorded expenses for any period would be affected by changes in these factors and circumstances. A reduction in the estimated useful lives of the plant and equipment would increase the recorded expenses and decrease the non-current assets.

(ii) Impairment of Plant and Equipment

The Confederation assesses impairment of assets whenever the events or changes in circumstances indicate that the carrying amount of an asset may not be recoverable i.e. the carrying amount of the asset is more than the recoverable amount.

Recoverable amount is measured at the higher of the fair value less cost to sell for that asset and its value-in-use. The value-in-use is the net present value of the projected future cash flow derived from that asset discounted at an appropriate discount rate. Projected future cash flows are based on the Confederation's estimates calculated based on historical, sector and industry trends, general market and economic conditions, changes in technology and other available information.

As at end of reporting period, the Management Committee of the Confederation are of the opinion that there is no impact resulting from the impairment review by the management.

(iii) Impairment of Loans and Receivables

The Confederation assesses at the end of each reporting period whether there is any objective evidence that a financial asset is impaired. To determine whether there is objective evidence of impairment, the Confederation considers factors such as the probability of insolvency or significant financial difficulties of the debtor and default or significant delay in payments.

Where there is objective evidence of impairment, the amount and timing of future cash flows are estimated based on historical loss experience for assets with similar credit risk characteristics. The carrying amount of the Confederation's loans and receivables at the end of the reporting period is disclosed in Note 4 to the financial statements.

(iv) Income Taxes

Significant judgement is required in determining the capital allowances and deductibility of certain expenses during the estimation of the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred income tax provisions in the period in which such determination is made.

(v) Leases

The Confederation assess at lease commencement by applying significant judgment whether it is reasonably certain to exercise the extension option. The Confederation considers all facts and circumstances including their past practice and any cost that will be incurred to change the asset if an option to extend is not taken, to help them determine the lease term.

The Confederation also applied judgement and assumptions in determining the incremental borrowing rate of the respective leases. The Confederation first determine the closet available borrowing rates using significant judgement to determine the adjustments required to reflect the term, security, value or economic environment of the respective leases.

13. FINANCIAL INSTRUMENTS

The Confederation’s financial risk management policy seeks to ensure that adequate financial resources are available for the development of the Confederation’s whilst managing its financial risk including liquidity and cash flow risk. The Confederation operates within guidelines that are approved by the Boards and the Confederation’s policy is not to engage in speculative transactions.

The main areas of financial risks faced by the Confederation and the policy in respect of the major areas of treasury activity are set out as follows: -

(a) Liquidity and cash flow risk

The Confederation maintains a certain level of cash and cash convertible investments to meet its working capital requirements.

(b) Foreign exchange risk

The Confederation is exposed to foreign current risk as a result of its normal operation activities when the currency domination differs from its functional currency.

The Confederation maintains a natural hedge, wherever possible, by depositing foreign currency proceeds from receipt into foreign currency bank account which will preliminary be used for payments in the same domination. Foreign exchange exposures in transactional currencies other than functional currency of the operating entities are kept to an acceptable level.

(c) Credit risk

Cash deposits and other receivables may give rise to credit risk which requires the loss to be recognised if a counterparty defaults on its obligations. The Confederation's exposure to credit risk arises primarily from other receivables. For other financial assets (including cash and bank balances), the Confederation minimises credit risk by dealing exclusively with high credit rating counterparties.

The credit risk with respect to other receivables are managed through the application of credit approvals, credit limits and monitoring procedures. Credit is extended to the customers based upon careful evaluation of the customer's financial condition and credit history.

The Confederation's normal credit term granted to members ranges from 30 to 60 days. Any other credit terms are assessed and approved on a case-by-case basis depending on the length of trading relationship, the volume of trade and other management considerations.

(d) Fair values

The carrying amounts of cash and cash equivalents and other receivables and other payables approximate fair value due to the relatively short to USD nature of these financial instruments.

- The Power of Asia : We feature our Mas in terms of their current state and challenges as well as their goals for the future. In this feature we talk with the new President, Secretary General and National Team Coach.

Social Media Performance Review

Below is our performance during 2020 based on followers’ growth and engagement by Facebook, Instagram, YouTube and Hootsuite analytics.

1. Facebook Analytics

Over the course of 6 months, we have reached 10.152 followers composed of 37% female and 62% male followers.

Our followers have increased by 2.139

Our contents received 38k responses, among which 6k are shares which means we are reaching a lot further than our fans.

2. Instagram Analytics

Within 6 months our contents have built from zero to 1.500 Instagram followers, composed of 25% female and 75% male followers.

Our contents received 7.4k engagements (likes and comments).

3. Twitter Analytics

Over the course of 6 months, we have reached 5.1k fans.

Our contents generated 3.2k engagements (likes and retweets).

4. YouTube Analytics

In the past, our YouTube has been inconsistent in featuring our tournaments.

In the last 8 months, we have only been able to produce 13 video contents due to cost constraints.

However, we have gathered 28.3k views in total of 2.500 hours (watch time) and gained 32 new subscribers

Our 8.416 subscribers are composed of 85% male followers and 15% female followers

5. Website Performance

We are unable to monitor since we haven’t installed Google Analytics on our website (which has to be done by the web developer).

In 2020 we have made some improvements to our website:

- i. We now can upload videos

- ii. Adding meta title and meta image so that when we share our article on Facebook, we'll be able to see the article title & image preview
- However, the website needs to be upgraded since the core engine is already outdated.
- i. Article's main image is cropped in the wrong size on our website's home page
 - ii. When sharing any article to Facebook or other social media, preview of title and image should be able to appear automatically without having to add meta title and meta image

Campaign Contents

Campaigns are developed with special theme, feature article, video content, activation and special graphics.

In 2020, we have launched 2 campaigns to cover monumental events:

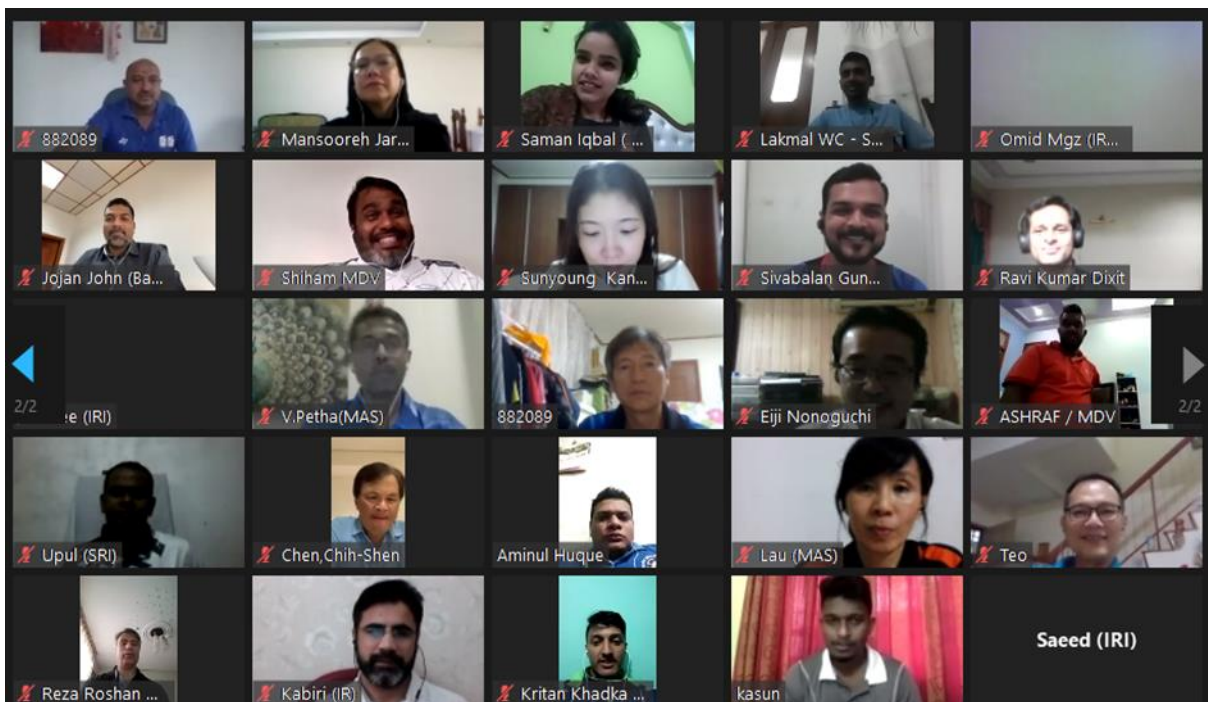

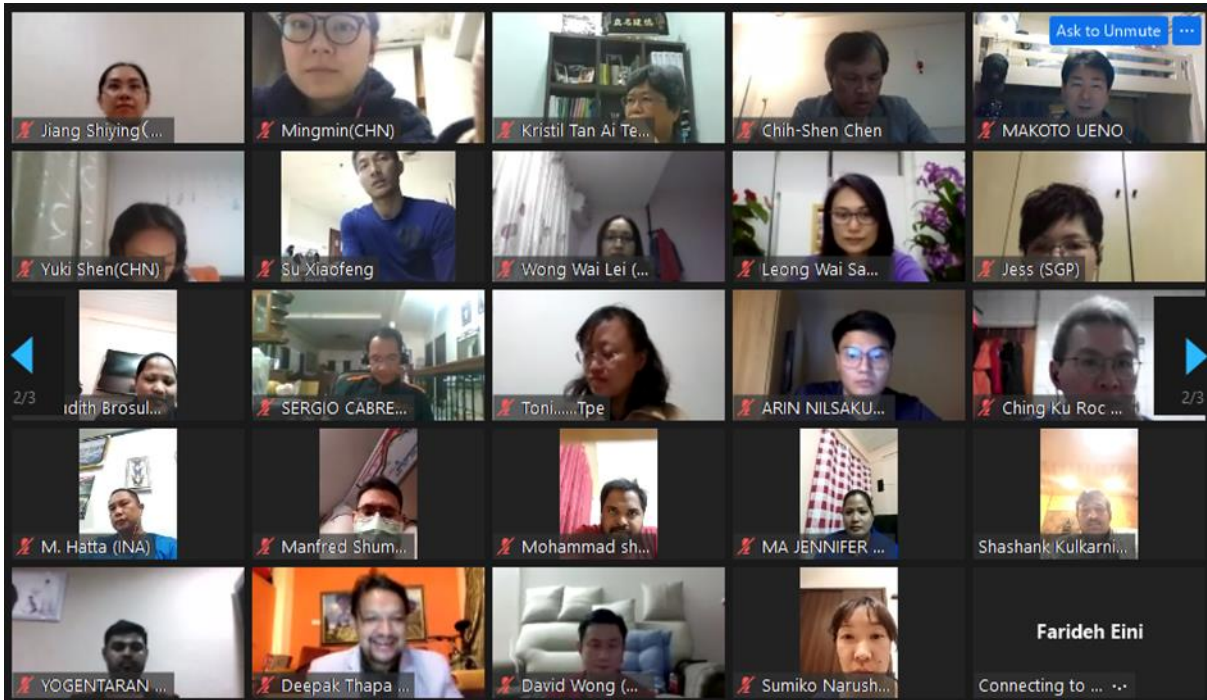

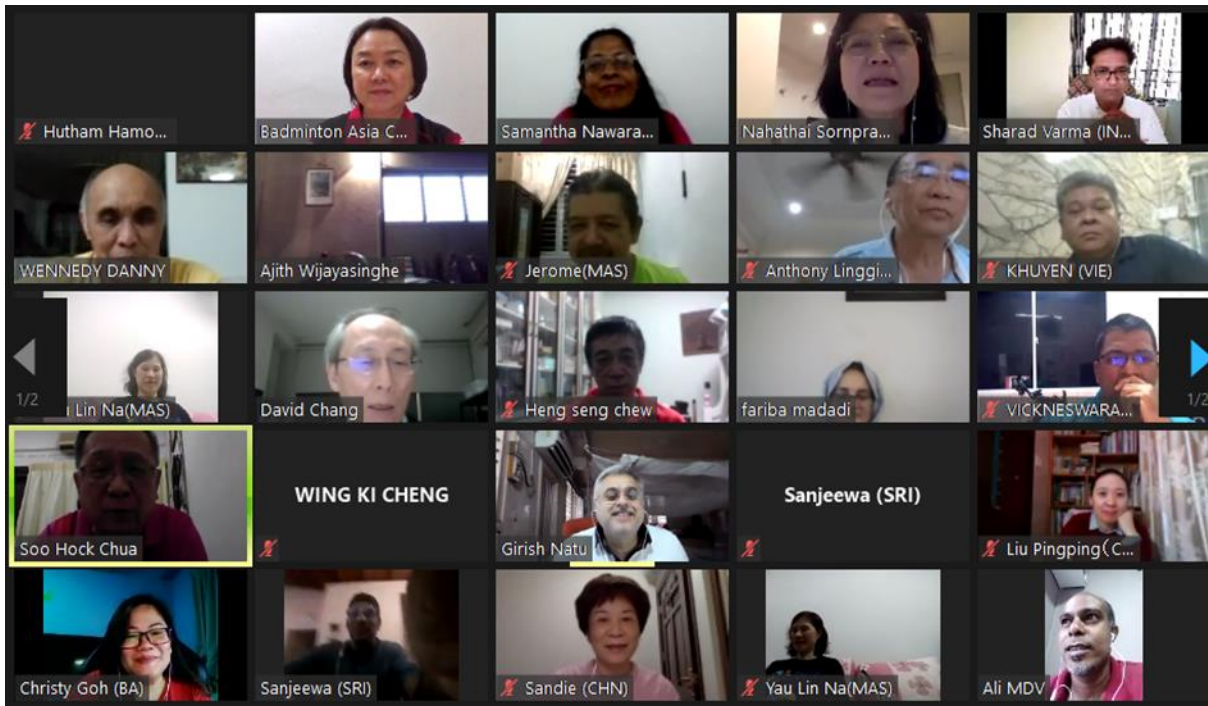

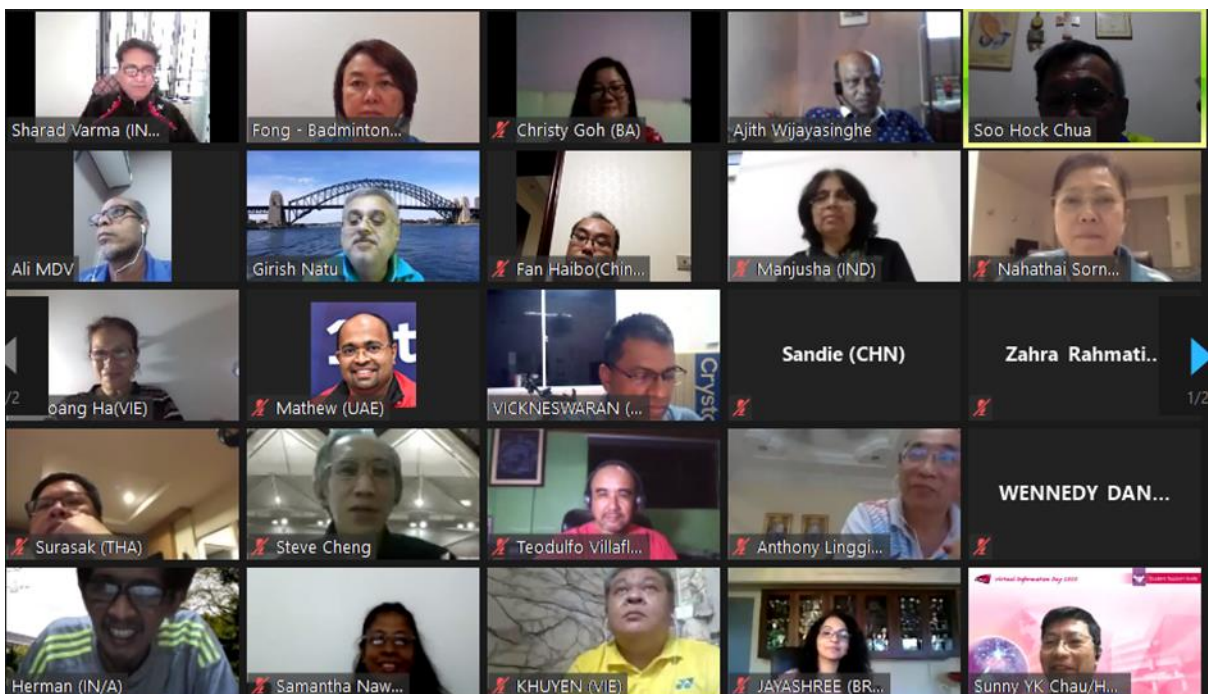

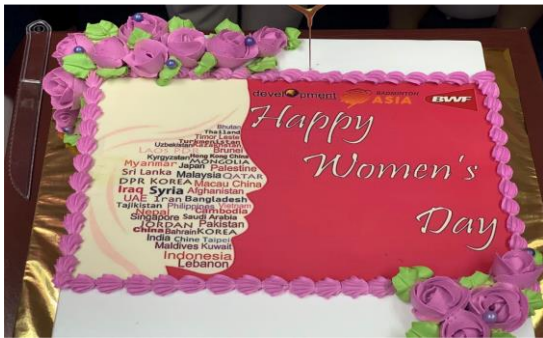
5.0 2020 IN REVIEW

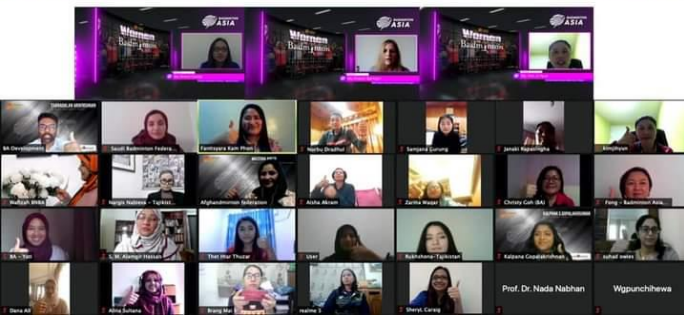

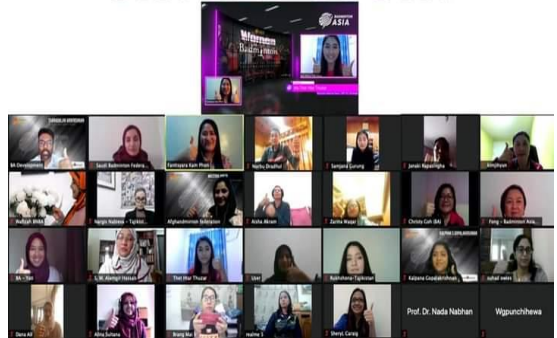

BADMINTON ASIA

Badminton Asia is the governing body of badminton in the continent in Asia. It is one of the five continental bodies under the flagship of Badminton World Federation (BWF).

Badminton Asia is one of the oldest confederations, being founded in 1959. Currently, Badminton Asia's operation office is headquartered in Petaling Jaya, Malaysia, and having 43 Member Associations and 1 associate member (Oman).

These Member Associations can be divided into five regions, namely West Asia, Central Asia, South Asia, East Asia and South East Asia.
