

After the closing date, the BWF Online Entry System will send notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline. The Member Associations should contact BWF immediately if such notice is not received by the Wednesday (next day of the entries closing date) by noon BWF Headquarters time (+08.00h GMT) following close of entries. If no objection is received by BWF by Thursday (second day after the entries closing day) 23.59 hours BWF Headquarters time (+08.00h GMT) following the close of entries, the entries shall be deemed to be correct. No complaints / objections shall be entertained after this point.

Clothing and advertising will be permitted in accordance with the competition regulations of Badminton World Federation.(GCR 20 - 24)					
The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member count. (GCR 23.3)					
MANDATORY CLOTHING REGULATIONS 1. Name of player is MANDATORY from the first day of the event. 2. From Quarter Finals onwards, doubles partners must wear clothing of the same colour. 3. From Quarter Finals onwards, opposing players must wear clothing of significantly different colors.					
On Court Doctor will be on duty throughout the competition at the tournament Venue.					
Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.					
Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Section 2.4 of the BWF Statutes ("Code on The Prevention Of the Manipulation Of Competitions") relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.					
To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.					
Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.					
GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary Processes."

On 10 January, 2023, the Department of Disease Control (DDC), Ministry of Public Health (MoPH) issued

"Public Health Measures for Foreign Travellers Entry into Thailand" as per the following:

- 1. Proof of vaccination is NO longer required.
- 2. Travellers from the listed countries required a negative RT-PCR test results before departure and a health insurance covering at least US\$10,000 for COVID-19 treatment that covers the duration of stay in Thailand plus 7 additional days.
 - Those with business arrangements, including flight crews and students, may have an official letter from the host or other form of insurance to cover such need.
 - The quarantine officer will randomly check the proof of insurance of travellers from the listed countries. If that travellers does not have proof of insurance, the traveller will have to purchase health insurance before immigration.
- 3. Holders of Thai passports and transit/transfer passengers are exempted from the health insurance checks.
- 4. The airlines must adhere to related regulation and comply with the guidance as appropriate such as asking passengers to wear mask at all times except during meals or emergency situations.
- 5. Any passenger having symptoms of COVID-19 on arrival shall be recommended to get a COVID-19 test at arrival.

The DDC has included **China Mainland** and **India** in its list of countries that require all travellers showing negative RT-PCR test results before departure.
